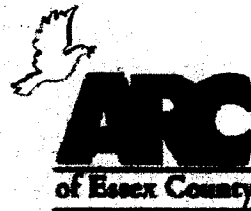

DIRECTIONS

From Route 80 West - Route 80 West to Exit 52. After exiting, make a right hand turn onto Passaic Avenue. Follow Passaic Avenue until the very end. Make a left onto Eagle Rock Avenue. At second light make a right onto Becker Farm Road. About 3/10 mile make a right onto ADP Boulevard.
