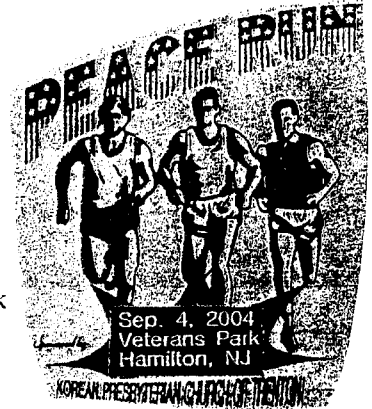


# -2nd Annual- 5K Peace Run and 1 Mile Fun Walk
