

WHAT IS SAFETY TOWN?

Safety Town of Northwest New Jersey, Inc., a non-profit organization, is a community initiative comprised of leaders from the corporate and public arena who had a vision to build Safety Town, a 6-acre, hands-on, interactive safety awareness and education program targeted to teach life-saving lessons to children pre-K-10 years of age. The program is modeled after the National Safety Town program. This vision is steadily becoming a reality thanks to collaboration with public and private entities represented on the Safety Town board as well as grassroots fundraising efforts.

Safety Town will be built in Jefferson Twp. in the Mahlon Dickerson reservation. It will feature a miniature town, complete with small buildings and streets, hands on classrooms for learning and a Survive Alive House to teach home fire safety and escape skills.

DIRECTIONS TO JOHANSON FIELD:

From Rte 80:

Take Exit 38 (46 East/Denville). Proceed on Rte 46 East just under 2 miles. Turn left toward Mountain Lakes onto the Boulevard (just past Paul's Diner). Go through Mountain Lakes on the Boulevard and bear left at the fork onto Elcock. Elcock becomes Powerville Road at Del's Village/Hawkins Place. Go approximately 1 mile and turn right to stay on Powerville Road. Turn left into RFL and Johanson Field.

From Downtown Denville:

Follow Diamond Spring Road until it becomes Rockaway Valley. Turn right onto Valley Road and then left onto Powerville Road. Turn left into RFL and Johanson Field.

From 287 North:

Take Exit 45 (Wootton Street). At stop sign, turn left. Follow Wootton Street up hill to the end. Turn right onto Oak. Follow to end. Turn right onto Powerville Road. At fork, turn right to stay on Powerville Road. Turn left into RFL and Johanson Field.

From 287 South:

Take Exit 45. At stop sign, turn left. At second light, turn right onto Wootton Street and follow directions above.
