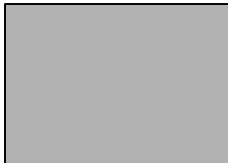

 **Directions to Morristown Running Co. (for packet pickup):**

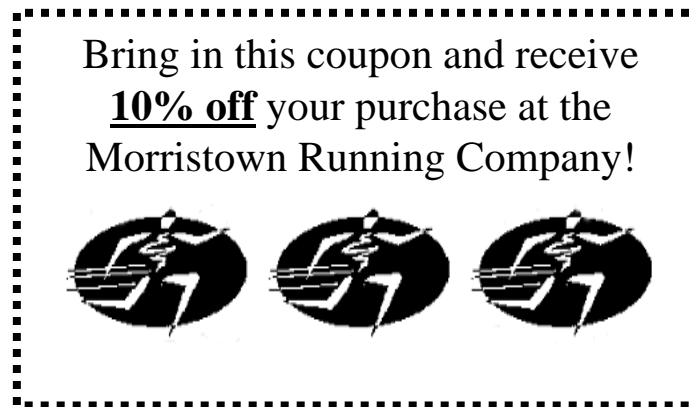
