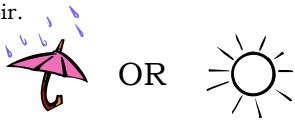

**AWARDS**

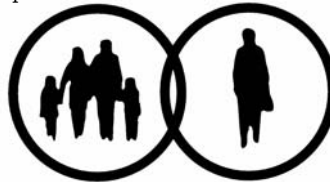
Top three overall male & female; Top male and female in each age group.
