The evening is going to be a fun-filled competition. We will kick it off with a foot clinic and complimentary foot analysis provided by our official race specialty running shop —Runner's High.



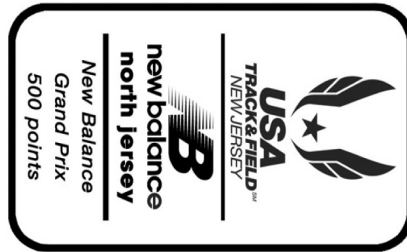

Directions:

From the North, take Route 287 South to Route 24 East. Take exit 2B to the Columbia Turnpike/Route 510, and from there make a left onto Hanover Road. ADP's new building is number 71.

From the South, take the NJ Tpk North to Exit 14, (Route 78 West), or the Garden State Pkwy to Exit 142. From 78 West, get onto Route 24 West to Exit 2B, Columbia Tpk/Route 510, and turn left onto Hanover Road. ADP's new building is number 71.

From the East, take Route 280 West to Exit 4A (Eisenhower Pkwy South). Bear right off the ramp and continue to the first traffic light (Eagle Rock Avenue). Make a right at the light and then a left onto River Road. Remain on River Road for a few miles. After you cross over Route 10, the road will come to an end and you will make a right onto Mt. Pleasant Avenue. At the next light, turn left onto Hanover Road. ADP's new building is number 71.

From the West, take Route 80 East to Route 280 East to Exit 4A (Eisenhower Pkwy South). From Exit 4A, you can follow directions, "From the East" above to number 71 Hanover Road.
