- Description:** A USATF sanctioned and certified 5K Run on a scenic course at Giralda Farms, rain or shine.
- When:** Wednesday, May 25, 2011 at 6:30 p.m. (check-in from 5:00 p.m.- 6:00 p.m.).
- Where:** Giralda Farms, Madison, NJ—entrance is on Dodge Drive off Route 124 in Madison. Directions on back.
- Entry Fee:** Pre-registration: \$15.00—Post-registration: \$20.00 (Postmarked after May 20, 2011).  
USATF Members—\$2 discount pre-entry only. Make checks payable to: **Project Community Pride**.

- Amenities:** All pre-entered runners will receive t-shirts and an assortment of Pfizer items. Water and port-a-johns available at check in. **No locker rooms or indoor restrooms will be available.** Multiple aid stations available on the course. Computer scoring and postcard results sent out after the race. Food and drink will be available after the race.
- Awards:** First three overall male and female, first three male and female 14 & under, 15-19, 20-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-79 and 80 & over.
- Teams:** Corporate team awards: male, female and coed. No team changes day of the race. You may enter as many teams as you like. There is no additional charge for team entries.
- Packet P/U:** May 23 and 24 from 10:00 a.m. to 5:00 p.m. and May 25 from 10:00 a.m. to 3:00 p.m. at The Sneaker Factory, 308 Millburn Avenue, Millburn, NJ. Packets can also be picked up at race registration starting at 5:00 p.m. at Pfizer.

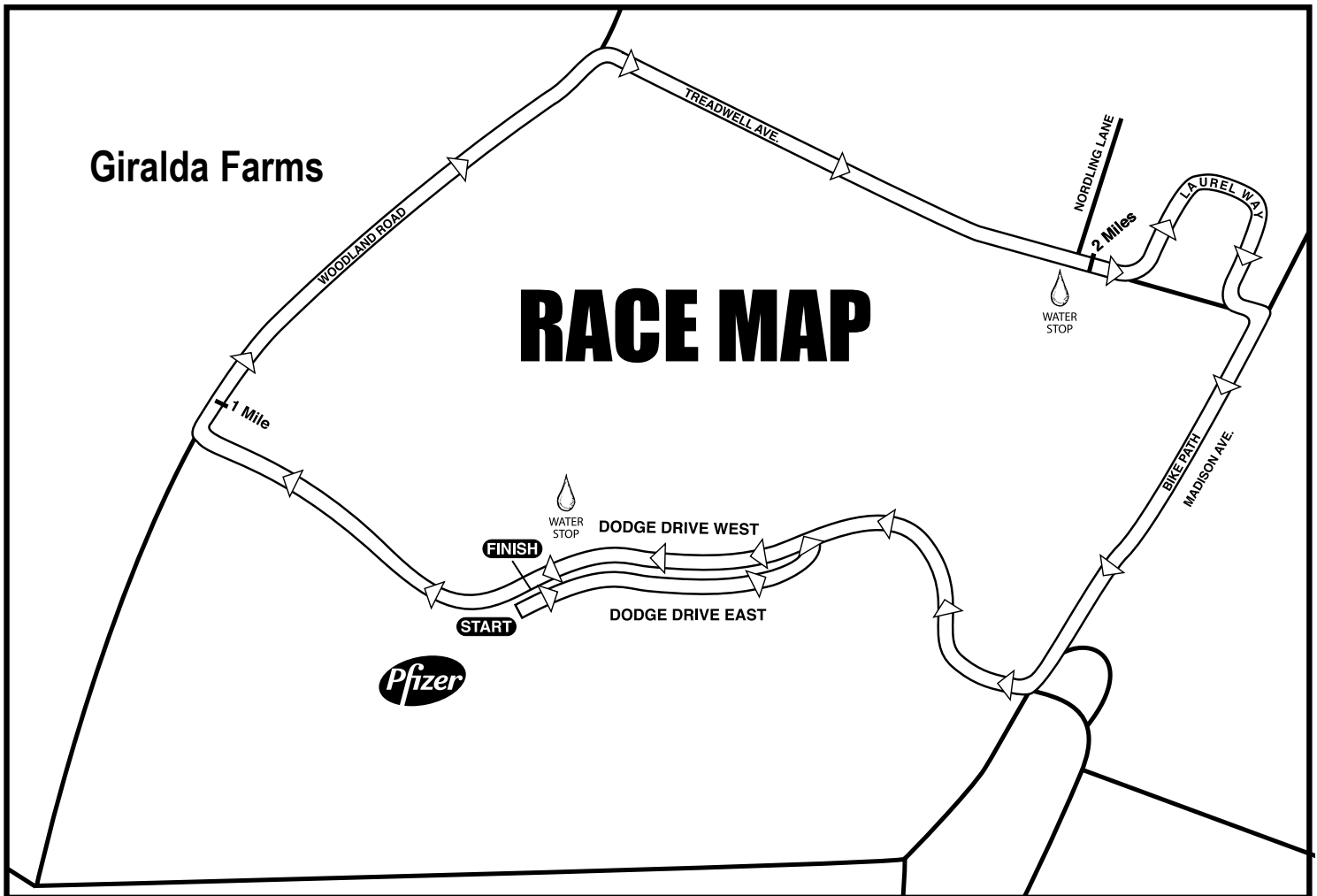

# Directions



## **From Route 80 or Route 287 South:**

Take Route 80 to Exit 43 onto Route 287 South. Proceed South on 287 to Exit 35 (Madison Ave). Make a left at the light onto Madison Avenue. Continue on Madison Avenue, Route 124, to 6th light (Dodge Drive). Turn right at Dodge Drive into Giralda Farms. Follow signs for race parking.

## **From Route 287 North:**

Take Route 287 North to Morristown Exit 35 for South Street, Madison Avenue. Make a right at the first light and make the first left onto Woodland Avenue. Continue 2 miles to the back entrance of Giralda Farms on your left. Follow signs for race parking.

## **From the NJ Turnpike/Route 78/Route 24:**

Take the NJ Turnpike to Exit 14. Follow signs to Route 78 West. Take Route 78 West to Route 24 West. Take Route 24 to Exit 2A (approximately 7 miles). Exit onto Route 510 West Columbia Turnpike (towards Morristown). At the first light, make a left onto Park Avenue. Continue through 4 traffic lights, turn right onto Danforth Road (1/4 mile after the 4th light). Proceed to end, cross Madison Avenue into main entrance of Giralda Farms site. Follow signs for race parking.
